Inspire – how has your champion inspired others regarding SuDS?	Bridget is a (deceptively) quiet, but powerful public speaker, explaining technical issues simply and effectively. She is a frequent speaker at SuDS related events, including for CIRIA. She coaches and supervises junior staff in her company and she supervises BSc and MSc students undertaking dissertations in SuDS.
Inform – how does your champion share good practice?	Bridget's knowledge base is extensive, enabling her to write, speak and teach thoughtfully and with clarity, to all, from government leaders to students. In addition to the above, she was the principal author of the SuDS Manual. She was the principal author of the recommended updated SuDS standards for England (just completed). She delivers HR Wallingford's training courses in SuDS both in the UK and overseas (including China and their sponge cities). She acts as a peer reviewer of others CIRIA guidance and she often writes and presents papers on SuDS.
Influence – how has your champion dealt with challenges and shared their enthusiasm about SuDS?	Bridget never comes across as being daunted by (often) being the sole woman in a male-dominated engineering environment. She is an acknowledged authority, whose enthusiasm and extensive knowledge has won the respect of industry. She works with fellow SuDS experts in the industry to promote best practice by carrying out research, developing guidance, providing training, providing advice to UK governments, their agencies and other researchers, directly employed or via advisory groups.
